Front Side. Refer to sample at right

- A. Date of sale: day/month/year.
- B. Retailer's name, address, city, state and zip where you purchased the boat.
- C. Make of boat: use name from boat decal. Model of boat: located on the capacity tag.
- Model year: the last two digits of the Hull Identification Number. For example: 14 = 2014.
- E. Year built: the third number from the last of the Hull identification Number. For example: 4 = 2014
- F. Hull identification number: this number is located on the outside of the boat in the back on the hull. It is a twelve-digit number that begins with KLI.
- G. Length: found in owner's manual or point-ofpurchase label.
- H. Propulsion: if your boat has a motor or will be used with a motor check outboard fill in the horsepower (hp) rating of your motor. Otherwise, check manual.

- I. Fill out your name and address.
