BASS PRO SHOPS AND CABELA'S CUSTOMER SATISFACTION SURVEY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY: Open to legal residents of the 50 United States (excluding RI) and District of Columbia ("U.S.") and Canada (excluding Quebec) who are 18 years of age or older at time of entry.
