**BASS PRO SHOPS AND CABELA'S  
CUSTOMER SATISFACTION SURVEY SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.  
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. ELIGIBILITY:** Open to legal residents of the 50 United States (excluding RI) and District of Columbia ("U.S.") and Canada (excluding Quebec) who are 18 years of age or older at time of entry. Employees of Bass Pro Outdoor World, LLC; Bass Pro Shops Canada (Calgary), Inc., a Canadian corporation; Bass Pro Shops Canada, Inc., an Ontario corporation (the "Sponsors"), Cabela's Wholesale, LLC ("Cabela's"), and their respective subsidiaries, agencies, affiliates and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household of such individuals are not eligible. Void in Rhode Island, Quebec and where prohibited.
  
- 2. PROMOTION PERIOD:** The Promotion starts March 1, 2025 at 12:00:00 am (midnight) Eastern Time ("ET") and ends on February 28, 2026 at 11:59:59 pm ET ("Promotion Period"). The Promotion consists of twelve (12) separate periodic sweepstakes (each, a "Sweepstakes Period") as set forth in Section 4 of these Official Rules. The Promotion is subject to all applicable federal, state, provincial, territorial, and local laws and regulations. The Sponsors' computer is the official Promotion Period clock.
  
- 3. METHODS OF ENTRY:** An Entrant may enter using one (1) of the following two (2) methods of entry:
  - A. Entry Method 1:** After completing a purchase at a participating Bass Pro Shops or Cabela's retail store, the customer will receive an invitation to participate in a survey ("Survey"). This invitation will be printed on the store receipt as well as sent via email, if the entrant's email address was provided to the Sponsors. The customer must log on to the URL provided on the receipt and/or email invitation and complete the Survey within fourteen (14) calendar days from the date of purchase. After completing the Survey, the customer will be asked if he or she wishes to enter the Promotion. If the customer is an eligible Entrant and wishes to participate in the Promotion, he or she must then enter the requested registration information, which may include, but is not limited to: complete first and last name, valid e-mail address, complete street address, city, state/province, zip/postal code, telephone number and date of birth. After entering this information, the Entrant must click on the submit button to receive one (1) entry into the Sweepstakes Period running when the entry is received. Limit one (1) entry per invitation. Purchase must be made in-store by February 28, 2026. As long as the purchase is made on or before February 28, 2026, Entrants will still have fourteen (14) calendar days from the date of purchase to enter the last Sweepstakes Period. For example, a customer who has made a purchase on February 28, 2026 will have until March 15, 2026 to complete the survey and receive an entry into the last Sweepstakes Period.
  
  - B. Entry Method 2:** To enter without making a purchase, hand print your name, complete address, telephone number and date of birth on a 3" x 5" piece of paper and mail it to be received by the deadline listed in the schedule in Section 4 to: BPS/Cabela's Survey, c/o PMI, PO Box 172, Newtown, CT 06470-0172, USA.

Regardless of the method of entry, the entry date will be the date that the Entrant either completes the Survey or receives an entry by the alternative method of entry, not the date of the receipt or purchase. Therefore, it is possible for an Entrant to complete a purchase during one Sweepstakes Period and receive an entry into the next Sweepstakes Period. Regardless of the method of entry, an Entrant may only enter the Promotion once per calendar day during the Promotion Period. A calendar day starts at 12:00:00 am ET (midnight) and ends at 11:59:59 pm ET each day during the Promotion Period.

To be eligible for a Prize, the Entrant must comply with these Official Rules. Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, non-deliverable for any reason, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an Entrant, the authorized account holder of the e-mail address used to enter will be deemed to be the Entrant. "Authorized account holder" is defined as the person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entry constitutes permission (except where prohibited by law) to use Entrant's name, city, state/province, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval.

- 4. RANDOM DRAWING:** On or about each of the Random Drawing Dates below, a random drawing will be conducted by Sponsors from among all eligible entries received during each Sweepstakes Period. Each Winner will be deemed a potential Winner pending verification of eligibility and compliance with these Official Rules. Entrants must enter during each Sweepstakes Period to be eligible to win a Prize for that Sweepstakes Period. **Entries will not be carried over from one Sweepstakes Period to the next Sweepstakes Period.**

**Purchase must be made in-store by February 28, 2026, but customers will still have fourteen (14) calendar days to enter the Promotion.**

**5. PRIZES/APPROXIMATE RETAIL VALUE/AND ODDS OF WINNING:**

**Prizes (1 per Sweepstakes Period):** Each Sweepstakes Period, one (1) Winner will receive a USD\$500/CAD\$500 Bass Pro Shops/Cabela's Gift Card ("Prize"). Each Prize will be issued in the currency of the winner's country of residence. ARV of each Prize is USD\$500/CAD\$500.

**General Conditions on Prizes:** Use of gift cards are subject to terms and conditions associated with the cards. Each Winner must protect his/her Prize and treat the Prize as he/she would any other valuable document. Prize will not be redeemed or exchanged for cash, except where required by law. Prize will not be replaced or replenished if it is lost, stolen, damaged, destroyed or used without Winner's permission and will be voided if altered or defaced. Sponsors are not responsible for lost, stolen or unauthorized use of Prize. Limit one (1) Prize per household for the entire Promotion Period. After winning a Prize, the household will no longer be an eligible Entrant for all the future Sweepstakes Period Random Drawings. Prizes are non-transferrable and non-substitutable, except by Sponsors in their sole discretion. Sponsors reserve the right to substitute a similar Prize of comparable or greater value. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of a Prize(s) are the sole responsibility of Winner(s). If a Prize is unclaimed within a reasonable time

after notification from Sponsors, as determined by Sponsors in their sole discretion, it will be forfeited, and, time permitting, an alternate Winner may be selected from the remaining eligible entries at Sponsors' sole discretion.

- 6. WINNER NOTIFICATION AND FULFILLMENT:** Potential Winners will be notified by telephone, e-mail, or mail, at Sponsors' sole discretion, on or about the Random Drawing Dates set forth in Section 4 of these Official Rules via the contact information provided at the time of entry.

If a potential Winner is a Canadian resident, he/she must first correctly answer without assistance a mathematical skill-testing question before being declared a Winner. The skill-testing question and any other requested winner paperwork must be returned within the time period stated in the winner notification or the prize may, in the Sponsors' sole discretion, be forfeited and awarded to an alternate potential winner.

If a potential Winner is ineligible for any reason, then the potential Winner will be disqualified and an alternate Winner may be selected.
